

CODE OF CONDUCT

Self-Employed Sole Trader/Independent Contractor for BlocSquared

COMMUNICATIONS:

Your communications and other interactions with prospect customers & existing customers and website users should increase their trust in BlocSquared.

DATA:

We are asking customers & users to trust us with their personal information. Preserving that trust requires you to respect and protect the privacy and security of that information. Know your responsibilities. Collect, use, and access user personal information responsibly, using applicable data protection laws.

RESPONSIVE:

Take pride in responding to communications from our users, whether questions, problems, or compliments. If something is broken, try to fix it.

SHARE:

Any time you feel our customers or users aren't being well-served, step forward when the interests of our users are at stake and share this feedback directly with BlocSquared

CONFLICT OF INTEREST:

If you are in a situation in which competing loyalties could cause you to harm the interests of BlocSquared we urge you to either speak to BlocSquared or think about relinquishing your Affiliate Code.

CONFIDENTIAL INFORMATION:

Apply your best judgment in making sure you do not disclose unnecessary information.

Just as you are careful not to disclose confidential information, it is equally important not to disclose any confidential information from our partners, suppliers, users or customers.

OUTSIDE COMMUNICATIONS:

All BlocSquared Affiliates must be extremely careful about disclosing confidential proprietary information. In general, making any external communication or disclosure, of inner workings or sensitive data is to be avoided.

IP:

Unauthorised use of BlocSquared's intellectual property rights (i.e. trademarks, logos, copyrights, trade secrets, "know-how", and patents) can lead to loss of value. You must respect all copyright and other intellectual property laws, including laws governing the fair use of copyrights, trademarks, and brands. You must never use BlocSquared's logos, marks, or other protected information or property

for any business or commercial venture without pre-clearance from BlocSquared. It is strongly encouraged that you report any suspected misuse of trademarks, logos, or other intellectual property.

Likewise, respect the intellectual property rights of others. Inappropriate use of others' intellectual property may expose BlocSquared and you to criminal and civil fines and penalties. Please seek advice from BlocSquared before you solicit, accept, or use proprietary information from individuals outside the company or let them use or have access to proprietary information.

SIGNING:

As an independent contractor, you are not authorised to sign any contracts on behalf of BlocSquared. Never sign any contract on behalf of BlocSquared unless:

You have been explicitly authorised to do so by BlocSquared.

The contract has been approved by BlocSquared.

RECORDS:

Keeping a record of your Bloc buyers (if done), must be done, in accordance with relevant data protection laws.

CONCLUSION:
